

■ From the Desk of the Director

"Change is inevitable." "The only thing that stays the same is change." If you google "quotes about change" you will be inundated with hundreds of philosophical takes on the subject. Most reflect on the advantages of being open to change. Well, the Boone Area Chamber of Commerce is about to change an element of membership that has stood untouched and somewhat forgotten for years: our dues structure and program investments. 
PRESIDENT'S PERSPECTIVE
